AIMS AND OBJECTIVES - DAY 2

Aims

The second day will be aimed at those involved in the more technical and strategic aspects of dealing with alcohol related problems, with specific focus on the Licensing Act 2003.

Objectives

At the end of the session delegates will be better able to:

- Identify Licensing Authority, Responsible Authorities and Authorised Persons
- Identify Licensing Objectives, Licensable Activities, Types of Authorisations, Licence Holders, Personal Licence Holders, Designated Premises Supervisors
- Explain Licence applications and Operating Schedules
- Describe Representations and importance of relevant Licence Conditions
- Identify main offences under the Act and statutory rights of entry
- Meaningfully inspect premises
- Define the Integration of Licensing Law and other measures of night time economy management, partnership working
- Identify options for and tactically action plan dealing with Problem People, Problem Premises and Problem Areas
- Identify who 'sells' alcohol under the law
- Identify current and future developments including the Violent Crime Reduction Act
- Define offences under the Act, and particular offences of sales to drunken persons, children and targeting of problem premises
- Identify the types of closure order powers available
- Describe the Licence Review process and powers at Review
- Identify the Strategic Partners responsible for enforcement
- Explain how Strategic Partners can work together better to improve enforcement.



Outcomes

- Confidence in tactical and operational use of the Act
- Embracing competency levels defined in Skills for Justice in relation to the use of the Act
- Confidence in the integration of the Act into managing alcohol related crime and disorder strategies and policing plans
- Confidence and experience in the implementation of Closure Orders and Licence Reviews
- Confidence in targeting and dealing with problem premises.
